4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.

Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment of phosphodiesterase (PDE) 5 inhibitor overdose may include the following: Administer activated charcoal as a slurry. For hypotension, infuse isotonic fluids, dopamine, or norepinephrine. Nitrates are contraindicated due to the possibility of severe hypotensive reaction. Priapism is an emergency requiring immediate consult with a urologist. Hemodialysis or hemoperfusion are unlikely to be of benefit.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Do not wear protective garments in common areas (e.g., cafeterias) or out-of-doors.

Use a powered air-purifying respirator (PAPR) with HEPA filters, disposable outerware and head cover for spill cleanup. Choose respiratory protection appropriate to the task and the level of existing engineering controls.
