Description of first aid measures

If inhaled

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

SYMPTOMS: Symptoms of exposure to this compound include irritation of the skin. ACUTE/CHRONIC HAZARDS: This compound may be harmful by inhalation, ingestion or skin absorption. It may cause irritation. When heated to decomposition it emits toxic fumes of chlorine, carbon monoxide, carbon dioxide, hydrogen chloride gas and phosgene gas. (NTP, 1992)
