## SECTION 4: First aid measures

### **Description of first aid measures**

#### **General advice**

#### **If inhaled**

After inhalation: fresh air.

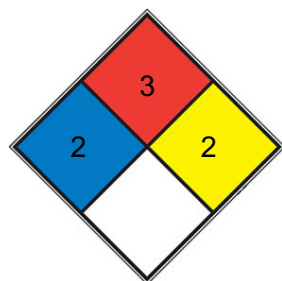
### Advice for firefighters
