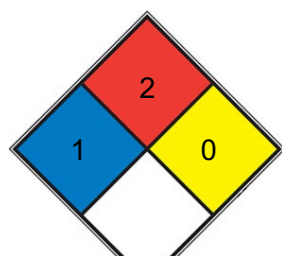

## SECTION 6: Accidental release measures

##### Body Protection
