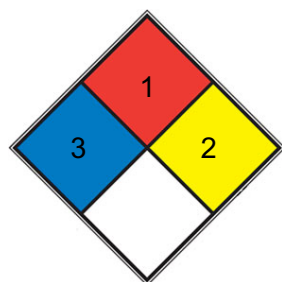

Absorption into the body leads to the formation of methemoglobin which in sufficient concentration causes cyanosis. Onset may be delayed 2 to 4 hours or longer.

To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

After absorption:

Tiredness, Cyanosis, agitation, Dizziness, ataxia (impaired locomotor coordination), Drowsiness, Unconsciousness, Coma

Systemic effects:

Risk of methaemoglobin formation with headache, cardiac dysrhythmia, drop in blood pressure, dyspnoea and spasms, principal symptom: cyanosis (blue discolouration of the blood).

Changes in the blood count Damage to:

Liver, Kidney, Central nervous system Effect potentiated by: ethanol

Under given conditions, contact with nitrites or nitric acid can lead to the formation of nitrosamines, which have shown themselves to be carcinogenic in animal experiments. This substance should be handled with particular care.
