Description of first aid measures

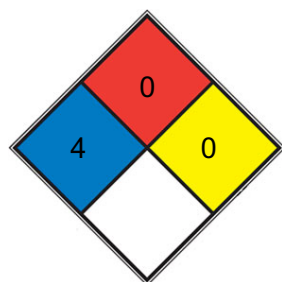
Advice for firefighters
