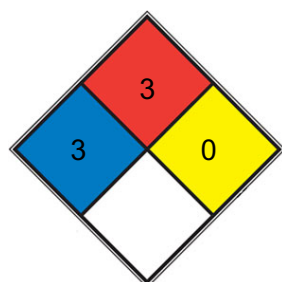

#### Body Protection
