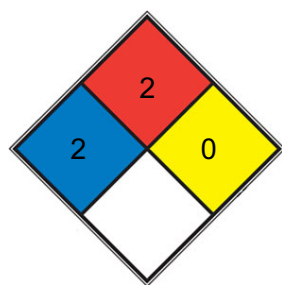

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning.
