If inhaled

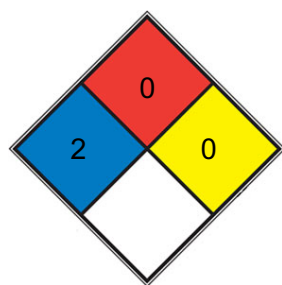
