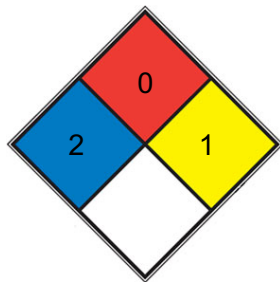

### **Waste treatment methods**

#### **Product**

Offer surplus and non-recyclable solutions to a licensed disposal company. Dissolve or mix the material with a combustible solvent and burn in a chemical incinerator equipped with an afterburner and scrubber.

#### **Incompatibilities**

Acids, acid salts; salts of iron and zinc, alkaloids, calomel and tartar emetic. Keep cool, below 38 C. Contact with inorganic acids may form CO<sub>2</sub>, heat, and dangerous spattering.

#### **Waste Disposal**

Slowly deposit in a large container of water. Add excess amounts of soda ash and let stand for 24 hours. Decant to another container, neutralize with hydrochloric acid, and drain with an excess of water. Ship to landfill.
