#### If inhaled

### **Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

## SECTION 12: Ecological information

### Toxicity

Toxicity to fish: LC50 - *Oncorhynchus mykiss* (previous name: *Salmo gairdneri*) - 13 mg/L - 96 h.

Toxicity to daphnia and other aquatic invertebrates: EC50 - *Daphnia magna* - 420 mg/L - 48 h.

Toxicity to algae: *Pseudokirchneriella subcapitata* (previous names: *Raphidocelis subcapitata*, *Selenastrum capricornutum*).

### Persistence and degradability

Bis(2-(2-butoxyethoxy)ethyl) adipate, present at 100 mg/l, reached 86 percent of its theoretical BOD in 4 weeks using an activated sludge inoculum at 30 mg/l and the Japanese MITI test(1), suggesting biodegradation is rapid.

### Bioaccumulative potential

An estimated BCF of 62 was calculated for bis(2-(2-butoxyethoxy)ethyl) adipate(SRC), using an estimated log Kow of 3.24(1,SRC) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is moderate(SRC).

### Mobility in soil

The Koc of bis(2-(2-butoxyethoxy)ethyl) adipate is estimated as 1,400(SRC), using an estimated log Kow of 3.24(1,SRC) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that bis(2-(2-butoxyethoxy)ethyl) adipate is expected to have low mobility in soil(SRC).

### Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
