If inhaled

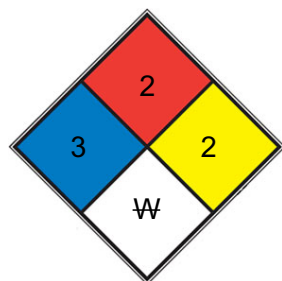
