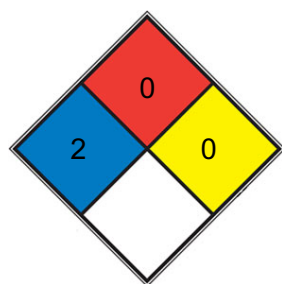

### **Waste treatment methods**

#### **Product**

Offer surplus and non-recyclable solutions to a licensed disposal company. #### **Incompatibilities**

Chlormequat chloride decomposes on heating or in fire forming nitrogen oxides, carbon monoxide, and hydrogen chloride fumes. This chemical decomposes on heating with strong aqueous alkali solutions forming trimethylamine and other gaseous products. Contact with strong oxidizers may cause fire and explosions. Attacks many metals in presence of water.
