## SECTION 4: First aid measures

### **Description of first aid measures**

#### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### **Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### **Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### **Following ingestion**

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

#### **Most important symptoms and effects, both acute and delayed**

SYMPTOMS: Symptoms of exposure to this compound may include skin and mucous membrane irritation; pancreatitis, depression of the formed elements of the blood; purpura, photosensitive dermatitis, necrotizing vasculitis, hyperglycemia, aggravation of diabetes mellitus; exacerbation of renal and/or hepatic insufficiency; lethargy, potassium loss, hyperglycemia, hyperuricemia, coma, chloride loss, lethargy, muscle cramps, acidosis, skin rash, salivary gland obstruction, psychosis, convulsions, leukopenia, jaundice, excessive amount of calcium in the blood, acute glomerulonephritis, anorexia, nausea, vomiting, cramping, diarrhea, dizziness, constipation, vertigo, paresthesia, headache, xanthopsia, hemolytic anemia, urticaria, fever, respiratory distress, including pneumonitis and pulmonary edema, anaphylactic reactions, glycosuria, muscle spasm, weakness, transient blurred vision and restlessness. ACUTE/CHRONIC HAZARDS: This compound may cause skin and mucous membrane irritation. When heated to decomposition it emits very toxic fumes. (NTP, 1992)

#### **Indication of any immediate medical attention and special treatment needed**

Thiazide diuretic overdose should be treated by immediate evacuation of the stomach followed by supportive symptomatic treatment and monitoring of serum electrolyte concentrations and renal function. Thiazide diuretic

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws
