To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated., Contact with proteolytic enzymes or bases cleaves p- nitroaniline (CAS# 100-01-6) from the peptide. p-Nitroaniline is readily absorbed by inhalation, ingestion, or skin absorption. It is a strong methemoglobin former. Cyanosis is the first manifestation of toxicity and can appear as early as 10 minutes or as late as 8 hours after ingestion. Other symptoms include: headache, nausea, vomiting, CNS effects, and cardiac effects. The blood, spleen, and liver are also affected.
