### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Fluribiprofen is rapidly and almost completely absorbed following oral administration. Peak plasma concentrations are reached 0.5 - 4 hours after oral administration.



### SECTION 6: Accidental release measures

#### Personal precautions, protective equipment and emergency procedures
