

The IRSL and SRSL for hydrazine sulfate is based on the data contained within EPA's IRIS hydrazine/hydrazine sulfate documentation, with adjustment of hydrazine inhalation value to account for the sulfate portion of hydrogen sulfate. Therefore the IRSL for hydrazine sulfate is 0.0008 µg/m3, with annual averaging.
