## SECTION 4: First aid measures

### **Description of first aid measures**

#### **General advice**

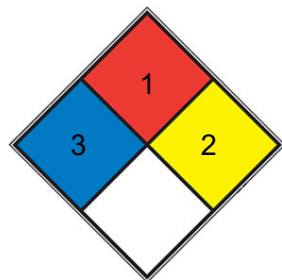

The purity of the saleable product is at least 97% combined isomers. See ICSC 0899. An added stabilizer or inhibitor can influence the toxicological properties of this substance; consult an expert. The effectiveness of phenolic inhibitors is dependent on the presence of oxygen. Store under air rather than inert atmosphere.
