

lodine is stable under normal temperatures and pressures. lodine may react violently with acetylene, ammonia, acetaldehyde, formaldehyde, acrylonitrile, powdered antimony, and liquid chlorine. lodine can form sensitive, explosive mixtures with potassium, sodium, and oxygen difluoride; ammonium hydroxide reacts with iodine to produce nitrogen triiodide, which detonates on drying.
