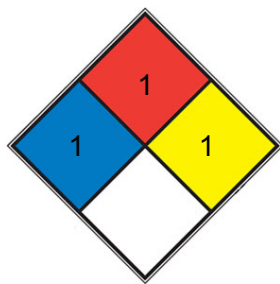

Additionally, ascorbic acid has been found to interfere with certain colorimetric assays by reducing the intensity of the color produced.
