#### General advice

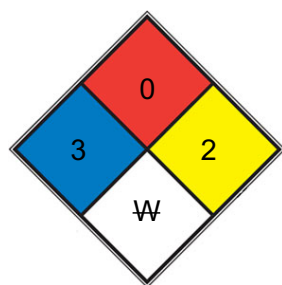
## Advice for firefighters
