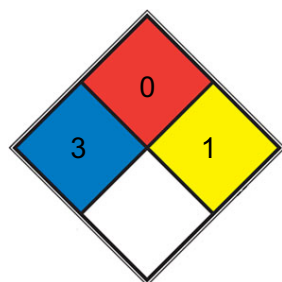

Diarrhea, vomiting, and neuromuscular effects such as tremor, clonus, and hyperactive reflexes may occur as a result of repeated exposure to lithium ion., Salivation, Nausea, Vomiting, Fever, Material is extremely destructive to tissue of the mucous membranes and upper respiratory tract, eyes, and skin.
