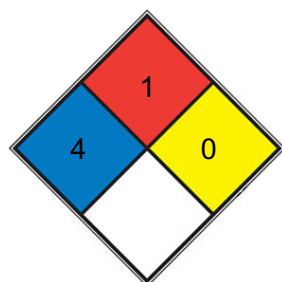

#### Eye/face protection
