### Description of first aid measures

#### General advice

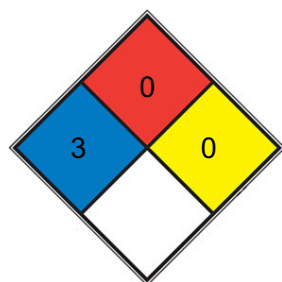
### Advice for firefighters
