## SECTION 4: First aid measures

### Description of first aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### **Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### **Following ingestion**

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

#### **Most important symptoms and effects, both acute and delayed**

**SYMPTOMS:** Symptoms of exposure to this compound include respiratory depression, sedation, occasional allergic reactions (particularly affecting the skin), purpura, exfoliative dermatitis, erythema multiforme (the Stevens-Johnson syndrome) and toxic epidermal necrolysis. Excessive exposure may cause nystagmus, ataxia and "hangover" with impaired judgment. In the elderly or in the presence of pain, paradoxical excitement, restlessness and confusion may occur. In children, irritability and hyperexcitability may occur. Toxic effects of overexposure may include prolonged coma, cardiovascular depression with hypotension and shock leading to renal failure, hypothermia and pyrexia. Characteristic erythematous or hemorrhagic blisters (bullae) rarely occur. Death may occur due to respiratory and circulatory failure. Inhalation of the dust may cause irritation of the upper respiratory tract. Ingestion may cause drowsiness, headache and irregular respiration. This compound may also cause skin and eye irritation. Nausea and vomiting may occur. Chronic effects of exposure to this compound include neurological and psychic functions that closely resemble those of alcohol. Symptoms of chronic poisoning include disorientation, mental confusion, ataxia, dizziness, depression and skin rashes. **ACUTE/CHRONIC HAZARDS:** This compound is harmful by ingestion or inhalation. When heated to decomposition it emits toxic fumes of nitrogen oxides and sodium oxide. (NTP, 1992)

#### **Extinguishing media**

## **SECTION 6: Accidental release measures**

#### **Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

#### **Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

### **Precautions for safe handling**

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Store the container tightly closed in a dry, cool and well-ventilated place. Store apart from foodstuff containers or incompatible materials.
