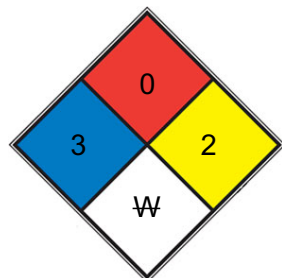

**Waste treatment methods****Product**

**Incompatibilities**

Incompatible with oxidizers; contact may cause fires or explosions. Keep away from alkaline materials, strong bases, strong acids, oxoacids, epoxides, alcohols, ammonia. Undergoes hazardous or violent reactions with metal hydroxides and oxides, formic acid, hydrogen fluoride and hydrofluoric acid, iodides, metals (in particular potassium and sodium), ammonia, and propargyl alcohol.

**Waste Disposal**

Decompose with water, forming phosphoric and hydrochloric acids. The acids may then be neutralized and diluted slowly to solution of soda ash and slaked lime with stirring then flush to sewer with large volumes of water.
