### **Description of first aid measures**

### General advice

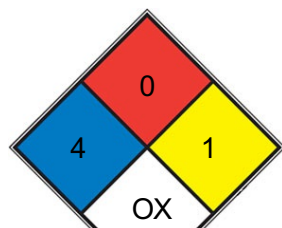
