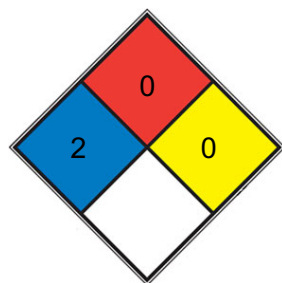

In humans, 2,4-pentanedione is reported to cause contact dermatitis and contact urticaria. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

Vanadium and its compounds generally cause irritations after eye and skin contact and mucosal irritations, coughing, and dyspnoea after inhalation. After absorption of toxic quantities changes in the blood picture, loss of weight, cardiovascular complaints.

Other dangerous properties can not be excluded.
